Introduction

Lextran, the Transit Authority of the Lexington-Fayette Urban County Government, has been in existence in its current form since December 1, 1973. It serves people and the community with mobility solutions. Lextran's fleet includes compressed natural gas, battery-electric, hybrid-electric, diesel and gasoline buses. Lextran operates 23 fixed routes, a door-to-door paratransit service and a vanpool/ridesharing program. Lextran operates in the consolidated city-county government of the City of Lexington and Fayette County Kentucky; representing a population of approximately 320,000. In 2005, taxpayers began supporting the system with local property taxes via a tax referendum. Lextran's fleet travels over just over two million service miles each year in regular fixed route service, which translates to nearly five million passenger trips per year.

Target Setting Methodology

Lextran utilized a multilayered approach to establish targets for its transit asset management plan. First, Lextran gathered relevant information about useful life benchmarks and the TERM scale for condition assessments of non-rolling stock. Second, using the Federal Transit Administration's suggested useful life benchmarks, Lextran evaluated cost of replacement of rolling stock to illustrate the current state of vehicles. Third, Lextran conducted an internal survey to gain perspective on how an ageing fleet impacts each department. Lastly, Lextran used the survey responses to foster internal discussion which lead to the final targets.
