Introduction

The Performance and Expenditure report describes the urban transportation planning activities performed or managed by the Lexington Area Metropolitan Planning Organization (MPO) - the MPO for the Central Kentucky urbanized area. The report covers Fiscal Year 2023, beginning July 1, 2022 through June 30, 2023. Applicable federal statues are 23 USC 134 and 49 USC 5303. The primary federal regulations are 23 CFR 450 and 49 USC 613.

The urban transportation planning area is Fayette and Jessamine counties and a small portion of southern Scott County. Table 1 identifies the area and population by county for the MPO planning area. The Lexington Area MPO region is part of the Lexington-Fayette Kentucky Metropolitan Statistical Area (MSA).

This report contains a brief purpose and descriptions of the products and activities undertaken by the MPO staff during Fiscal Year 2023 for each work element within the Unified Planning Work Program (UPWP). If quantifiable measures of number, time, and effort were available, they are listed with the work item. As required by KYTC Planning, work items are categorized by either a planning **product** or an **effort** although there is often crossover between these categories. Finally, if there were delays or problems in completing the products for the work elements they are listed in the summary at the end of each of each program element.

*Note: The Lexington Fayette Urban County Government (LFUCG) Division of Grants & Special Programs tracks and accounts for Lexington Area MPO expenditures and funding within the structure of the Lexington Fayette Urban County Government (LFUCG) grants accounting/reporting system. LFUCG Grants & Special Programs staff develops financial reports for the Lexington Area MPO. Coordination throughout the fiscal year occurs between MPO staff and LFUCG Financial Coordinators.

The MPO adheres to guidance and specific requirements of LFUCG Financial Coordinators to manage our federal transportation grants and charging of expenditures to UPWP elements and funding sources. The following is a summary of work items reported in FY-2023 MPO quarterly reports that follows the format of the FY-2023 Unified Planning Work Program.

Revisions to the FY 2023 Unified Planning Work Program (UPWP)

No revisions were necessary to the FY 2023 UPWP.

Element 1.0: Transportation System Data & Monitoring

Purpose:

To collect and analyze data and track the performance of the transportation system. To monitor transportation trends, rules, regulations and best practices to inform the transportation planning process.

Planning Activities identified in UPWP:

- Compile, analyze and maintain data (including GIS data) for the following:
 - US Census and other demographic/socioeconomic data
 - Population & employment growth
 - Regional travel patterns
 - Roadway characteristics and condition
 - Transit routes and ancillary facilities
 - Bicycle and pedestrian facilities
 - Freight-related data
 - Safety & crash data
 - Air quality data (ozone & particulate matter)
 - Congestion data (including travel time reliability and delay)
 - Transportation system usage data (traffic counts, bicycle/pedestrian counts, transit ridership, shared mobility device usage)
- Conduct an inventory of transportation-related data that is available for the region and facilitate a dialogue with the various agencies to identify opportunities for data sharing.
- Coordinate with KYTC and Lextran (5307 recipient) to monitor and report on national Transportation Performance Management metrics and progress toward meeting the established targets for safety, infrastructure condition, system performance, transit asset management and transit safety. Performance targets are set by Lextran and by KYTC and have been adopted and supported by the MPO. MPO adoption of safety targets and transit asset condition targets must occur annually. In FY 23, the MPO will evaluate the possibility of setting regional targets for safety performance measures.
- Monitor congestion and transportation system performance in accordance with federal planning requirements for a Congestion Management Process (CMP). Work with stakeholder groups to acquire and utilize the best available congestion-related data to inform the CMP. An RFP for a Transportation Data Analytics was issued in FY2022. An executed contract with the selected vendor is anticipated in Q4 of FY2022 and will extend through FY2023.
- Update and maintain the MPO's equity maps developed from US Census data to identify concentrations of Title VI, Environmental Justice (EJ), Underserved and Historically Disadvantaged communities, and Limited English Proficiency individuals in the MPO area.

These maps are used to inform project prioritization, project development and targeted outreach efforts. Work to update these maps began in FY 2022 when US Census 2020 data was made available and will be completed in FY2023.

- Assist Lextran and other federally funded transit entities in the Lexington area with data analysis and mapping, including maintenance of the GIS-based "Transit Route Facilities Inventory Database."
- Monitor the safety of the transportation system by mapping crash and incident data.
- Monitor the security of the transportation system by coordinating with emergency and public safety agencies regarding emergency management operations and disaster preparations.
- Review local air quality monitor readings to track trends and compliance with air quality standards.
- Identify and maintain maps of critical urban freight corridors in the Lexington MPO area in consultation with KYTC.
- Monitor corridors within the National Highway Freight Network and identify freight movements of significance within the MPO area.
- Update roadway functional classification maps in coordination with local and state agencies.
- Update the MPO's Urbanized Area Boundary as necessary per U.S. 2020 Census data.
- Update population, employment and network data in the Lexington Area MPO's Travel Demand Forecasting Model. Submit updates to KYTC.
- Monitor transportation-related rules, regulations, standards/guidelines and best practices.

- Current data sets and GIS layers of transportation-related data as described in the first bullet above (ongoing)
- Current Transportation Performance Management System data for the Lexington area and resolutions in support of statewide or regional performance targets (ongoing)

- Several staff began StreetLight tutorials for the transportation insight data platform that has been acquired in partnership with LFUCG Traffic Engineering.
- Attended NPMRDS Users Quarterly Technical Assistance Webinar.
- Continued work constructing and formatting GIS Story Map for the MPO website to show transportation projects.
- Attended State GIS conference in Lexington.

Second Quarter: October 1 2022 to December 31 2022

- Continued to review and collect relevant regional freight study data and to perform National Highway Freight Network (NHFN) and Primary Highway Freight System (PHFS) data analysis.
- Updated GIS layers for traffic counts, truck volumes, bridge condition, traffic crashes and severity.
- Verified/assigned road classes for new LFUCG street segments.
- Began StreetLight tutorials for the transportation insight data platform that has been acquired in partnership with LFUCG Traffic Engineering.
- Met with Traffic Engineering staff to prepare StreetLight Insight traffic data analytics and demos for the CMAQ committee meeting of December.
- Continued work constructing and formatting GIS Story Map for the MPO website to show transportation projects.
- Established access to the Kentucky State Police (KSP) crash reporting data source for transportation safety analysis.
- Analyzed KYTC and MPO area bridge condition data and recommended related performance targets for the MPO area.
- Adopted regional bridge condition targets for National Highway System roadways for 2024 and 2026. Submitted the TPC approved targets to KYTC and FHWA.
- Analyzed KYTC and MPO area pavement and travel time reliability data and presented recommended targets to the TTCC.
- Began to collect system data and conducting data analysis tasks for the 2050 Metropolitan Transportation Plan (MTP).

Third Quarter: January 1 2023 to March 31 2023

- Began collecting data and conducting analysis for the 2050 Metropolitan Transportation Plan (MTP).
- Several staff continued StreetLight tutorials for the transportation insight data platform.

- Reviewed FHWA's Guidebook for Incorporating Performance-Based Planning into the MTP and focused on mobility performance measures and targets, including safety and travel time reliability targets.
- Collected and analyzed highway fatalities, serious injuries, non-motorized fatalities & serious injuries and fatalities & serious injuries per 100 million vehicle miles traveled to assess regional trends as part of federal requirement to adopt regional safety targets for 2023.
- Presented staff recommendations to the CMAQ, TTCC and TPC for regional 2023 safety targets based on an analysis of the number of highway fatalities, serious injuries, nonmotorized fatalities & serious injuries, and the fatalities & serious injuries per 100 million vehicle miles traveled.
- Studied FHWA's Carbon Reduction Program (CARB) strategies that are required under the Bipartisan Infrastructure Bill (BIL).
- Reviewed technology updates sent from American Center for Smart Mobility Testing Site that has smart infrastructures for testing on-road smart vehicles. The center's technology site includes testing smart mobility of pedestrians, bicyclists, buses and other vehicles.
- Reviewed smart traffic, mobility and transportation planning programs that are parts of Smart Cities Connect initiatives that include Livability, Workability and Sustainability for cities and states alike.
- Requested and reviewed estimates for the installation of 5 Metro Count Bicycle and Pedestrian Counters at various trail locations.

Element 2.0: Project Identification & Prioritization

Purpose:

To identify and prioritize transportation projects and programs that are consistent with regional goals. To maintain a long-range multimodal Metropolitan Transportation Plan (MTP) and short-range Transportation Improvement Program (TIP) of projects. To ensure projects identified in the MTP and TIP are informed by the Congestion Management Process (CMP) and by regional plans that provide additional focus on bicycling, walking, transit, freight and corridor planning.

Planning Activities identified in UPWP:

- Maintain and implement the 2045 Metropolitan Transportation Plan (MTP). Modify and amend the MTP as needed.
- Utilize the MPO's Census-based maps to evaluate the priority, distribution and impact of transportation improvements and services when modifying and amending the MPO's MTP
- Utilize the MPO's Travel Demand Forecasting Model (TDFM) as necessary when evaluating and advancing projects in the MTP.
- Provide a description of national performance measures and targets in the MTP, including a system performance report.
- Begin work to develop the 2050 Metropolitan Transportation Plan including data collection and analysis, goals & objectives development.
- Review the MPO Congestion Management Process and recommended projects in coordination with developing the 2050 MTP. Ensure seamless integration of the CMP within the MTP.
- Determine methods to ensure the following is addressed in the 2050 MTP update: 1) there are strategies that help achieve national greenhouse gas reduction goals, 2) environmental considerations are included early in the planning process, 3) the MPO involves Federal Land Management and the Department of Defense agencies, as appropriate, in the development of the MTP.
- Work with KYTC to incorporate recommendations from the Local Road Safety Plan for Fayette County into the MPO's MTP, with an emphasis on disadvantaged communities.
- Conduct the Congestion Management Process (CMP) in accordance with all federal requirements. Integrate the CMP documentation into applicable planning documents, including the MTP.
- Identify proposed projects, programs and strategies to reduce congestion and improve system reliability through the Congestion Management Process and incorporate identified projects into the MPO's MTP and TIP. This will include strategies to reduce greenhouse gas emissions to achieve national climate change goals.
- Update and maintain a list of priority MTP projects in the KYTC Continuous Highway Analysis Framework (CHAF) database for prioritization during the development of the 2024 KYTC Highway Plan.
- Coordinate with the Lexington Fayette Urban County Government, KYTC and Lextran to jointly maintain the MPO area ITS Architecture.

- Conduct a Freight Study to assess the current and projected flow of goods within the region, identify freight bottlenecks and opportunities to improve the efficiency of regional goods movement. Includes the collection and analysis of freight-related data available for the Lexington Area. Data collection for the freight study began in FY 2022. The Transportation Data Analytics Platform acquired by the MPO at the end of FY 2022 will be utilized to further inform the freight study, currently planned for completion in FY2023.
- Coordinate with KYTC to update and maintain the Kentucky Freight Plan.
- Coordinate with Lextran to maintain the regional Coordinated Public Transit-Human Services Transportation Plan to improve transportation services and mobility for persons with disabilities, older Americans, and individuals with lower incomes.
- Work with Lextran and BGCAP to prioritize and program short and long range transit plans and projects in the TIP and MTP, with an emphasis on improving public transportation options for disadvantaged communities.

Element 3.0: Program & Project Implementation

Purpose:

To maintain a short-range Transportation Improvement Program (TIP). To coordinate with state and local agencies on program and project development to implement MPO plans and studies to achieve regional goals and desired outcomes. To identify opportunities to implement MPO projects, plans and programs through community and agency partnerships, grants and other funding programs, and during routine roadway operation and maintenance activities.

Planning Activities identified in UPWP:

- Maintain and implement the FY 2021-2024 TIP. Modify and amend the TIP as needed to add projects and update project information, phasing and cost estimates.
- Reconcile the FY 2021-2024 TIP with the enacted 2022 State Highway Plan. Work began
 when the State Highway Plan was finalized in Q4 of FY 2022 and will be completed in Q1
 of FY 2023.
- Utilize the MPO's Census-based equity maps to evaluate the priority, distribution and impact of transportation improvements and services when modifying and amending the MPO's TIP.
- Ensure the selection of TIP projects includes strategies that 1) help achieve national greenhouse gas reduction goals, 2) address environmental considerations early in the planning process 3) consider the environmental, community, and economic goals identified in these local Comprehensive, Small Area and Corridor Plans.
- Ensure that projects within the TIP that involve STRAHNET routes (I-64 & I-75) are prioritized and coordinated with Department of Defense agencies, as appropriate.
- Ensure that projects within the TIP that involve federal lands are coordinated with Federal Land Management Agencies and are prioritized, as appropriate.
- Provide a description of how projects identified in the TIP are anticipated to provide progress toward achieving national performance measures and targets for safety, infrastructure condition, system performance, transit asset management and transit safety.
- Monitor the status of dedicated STGB-SLX and STBG-TA projects and fund balances, particularly in light of new IIJA funding levels. Conduct a call for projects as available fund balances and apportionments warrant.
- Work with KYTC to incorporate recommendations from the Local Road Safety Plan for Fayette County into the MPO's TIP, with an emphasis on disadvantaged communities.
- Prepare an Annual Listing of Obligated Projects for all federally funded highway and transit projects that were obligated funding in the MPO's TIP during the prior fiscal year.
- Research, disseminate information and assist LPAs with federal grant applications for bicycle, pedestrian, transit and roadway projects.
- Prioritize CMAQ funding applications submitted by LPAs in the Lexington Area and submit rankings to the KYTC. Assist LPAs with air quality improvement calculations for CMAQ funding applications.

- Utilize the MPO's Travel Demand Forecasting Model (TDFM) to inform project development and design decisions.
- Develop partnerships with public, private and non-profit agencies to advance transportation projects and programs of mutual interest.
- Participate in project development meetings with the KYTC and local public agencies to provide input on projects goals and design alternatives.
- Work with federally-funded transit agencies including Lextran and their paratransit service provided by the American Red Cross (Wheels), Federated Transit Services of the Bluegrass (FTSB), and Blue Grass Community Action Partnership to implement and expand public transit programs and projects in the Lexington area, with an emphasis on disadvantaged communities.
- Coordinate with the City of Lexington, KYTC and Lextran to implement ITS technologies, projects and programs. Approve the annual scope of work for the ITS/CMS program funded through the STBG-SLX program.
- Coordinate with the City of Lexington, KYTC and Lextran to implement the Congestion Management / Bottleneck Study that was completed for the Lexington area in FY 2022. Work to integrate recommended projects into the MTP and TIP in FY 2023 (and beyond).
- Coordinate with various agencies to implement projects identified in the MPO's Regional Bicycle & Pedestrian Plan, with an emphasis on Complete Street projects in disadvantaged communities.
- Coordinate with the City of Nicholasville to implement the Jessamine County School Connector Study.
- Develop an MPO Complete Streets Policy and seek adoption from the TPC. Work on the policy began in Q3 of FY 2022 and is anticipated to be completed in Q2 of FY2023.
- Coordinate with the City of Lexington and KYTC on developing and adopting state and local Complete Street policies. Work on these policies began in Q3 of FY 2022 and is anticipated to be completed in Q3 of FY2023.
