SUBJECT: Notification of **Amendment #2** to the FY 2025–FY 2028 Transportation Improvement Program (TIP)

The following actions are contingent upon approval by the Lexington Area MPO Transportation Policy Committee (TPC) scheduled for February 26, 2025.

ACTION PROPOSED: TIP Amendment #2:

This amendment adds work phases for 13 new projects from the 2050 MTP to the TIP and supplementary funding for 5 existing projects in the TIP that the MPO staff has recommended for funding awards in the recent sub-allocated funds call for projects.
